Amplified Fine Arts Festival	\$62 fee for first category and \$7 for each additional category (7 <sup>th</sup> -12 <sup>th</sup> opportunity)		
Choir Fees	\$50 for ACSI Choral Festival plus room and board. Also see Amplified Fine Arts Festival		
Concurrent College Credit	\$195 per course for students who elect to earn college credit. Payments are made directly to Corban University during the month of October.		
High School Mission Trip	\$300-\$1,100 (\$100 deposit due October 30, 2021)		
Sports Fees	Middle School \$100 (Cross Country \$75) High School \$200 (Cross Country \$100) Sports fees are payable at the beginning of each season assessed through Sycamore.		
Bus Transportation	One way: \$250 per student; \$400 per family. Two Way: \$450 per student; \$700 for family. Punch cards: \$40 for 10 rides or \$4 per ride.		
Afternoon Enrichment Program	(Pre-4/K) \$5.50/hour (Keizer Campus only)		
Childcare	Before/After School Care (Pre-4-6 <sup>th</sup> ) \$4.50/hour – prorated by the half hour Late pick up fee: \$5.00/quarter hour. Late Payment Fee: \$25.00		
Homeschool Students	Application fee is \$50. Activity Fees are 150% of enrolled student fees. Tuition is prorated at 120% of enrolled student tuition.		
NSF Fee	A \$30 Fee will be assessed for NonSufficient Funds		
Credit Cards	A 3% fee will be assessed per transaction if a credit or debit card is used.		
Monthly Payment Option Fee	A \$45 Annual Processing Fee will be assessed for those families choosing to not pay tuition in full.

### **Payment Options**

1. Set up a payment method in Sycamore for a one-time withdrawal on July 5th. (There is no annual service fee to set up a one-time automatic withdrawal through Sycamore).
2. An eleven-payment automatic withdrawal (July-May) through Sycamore with an annual service fee of \$45. If you need to request a change to your account payment (date, amount, etc.), CCS must be given notice at least 2 business days prior to your payment date.
3. A twelve-payment automatic withdrawal (June-May) through Sycamore with an annual service fee of \$45.

\*\*\*Students are placed on official class lists and admitted to class only after payment arrangements have been made.

### **Need-based Financial Aid**

Interested families may apply at [www.online.factsmgt.com/aid](http://www.online.factsmgt.com/aid) once tax documents are filed for the prior calendar year.. To ensure access to Financial Aid discounts, returning families should submit their information by May 1st. Need-based tuition discounts apply only to full-time tuition (does not apply to fees and part-time tuition).

### **Late Payments**

- If there are non-sufficient funds in your account on the day of the month elected for payment withdrawal there will be \$30.00 returned payment fee payable to Crosshill Christian School plus your own bank charges.
- Any payment not received by the third attempt by Sycamore to make an electronic payment will make the account subject to the suspension of the educational services offered by CCS.
