Bus Transportation	One way: \$300 per student; \$500 per family. Two Way: \$500 per student; \$800 for family. <i>*Between Keizer church campus and South school campus only</i>
Band Fees	Miscellaneous costs for apparel and instrument upkeep.
Choir Fees	\$50 for ACSI Choral Festival plus room and board. Also see Amplified Fine Arts Festival
Amplified Fine Arts Festival	\$62 fee for first category and \$7 for each additional category (7th-12th opportunity)
Concurrent College Credit	\$65 per credit for students who elect to earn college credit payable to Corban University.
High School Mission Trip	\$300-\$1,100 (\$100 deposit due October 30, 2021)
*Continuous Enrollment (CE)	The non-refundable CE Fee is collected in January to reserve enrollment for the following school year. Payments may be made in full or spread out over 3 months (Jan/Feb/Mar).
Homeschool Students	Application fee is \$50. Activity Fees are 150% of enrolled student fees. Tuition is prorated at 120% of enrolled student tuition.
NSF Fee	A \$30 Fee will be assessed for NonSufficient Funds
Credit Cards	A 3% fee will be assessed per transaction if a credit or debit card is used.
Monthly Payment Option Fee	A \$50 Annual Processing Fee will be assessed for those families choosing to not pay tuition in full.

Financial Aid

Interested families may apply for need-based financial aid on our school website once tax documents are filed for the prior calendar year. To ensure access to Financial Aid discounts, returning families should submit their information by May 1st. Need-based tuition discounts apply only to full-time tuition (does not apply to fees and part-time tuition).
