Concurrent College Credit	\$65 per credit for students who elect to earn college credit payable to Corban University.
High School Mission Trip	\$300-\$2,500 (\$100 deposit due October 15)
*Continuous Enrollment (CE)	The non-refundable CE Fee is collected in January to reserve enrollment for the following school year. Payments may be made in full or spread out over 3 months (Feb/Mar/Apr).
NSF Fee	A \$30 Fee will be assessed for NonSufficient Funds
Credit Cards	A 3% fee will be assessed per transaction if a credit or debit card is used.
Monthly Payment Option Fee	A \$55 Annual Processing Fee will be assessed for those families choosing to pay monthly (paid directly to our FACTS payment plan partner).

Financial Aid

Interested families may apply for need-based financial aid on our school website once tax documents are filed for the prior calendar year. To ensure access to Financial Aid discounts, returning families should submit their information by May 1st. Need-based tuition discounts apply only to full-time tuition (does not apply to fees and part-time tuition).
